PREFACE

This standard was prepared by the Association's Committee on Abrasive Wheel Safety, to supersede (in part) AS 1788—1975, SAA Abrasive Wheels Safety Code.

This standard specifies safety requirements for the design and construction of abrasive wheels and the manufacture and installation of abrasive wheels and ancillary equipment. Particular requirements are given for the construction of guards for all equipment fitted with abrasive wheels and for the construction of flanges for use with abrasive wheels.

The selection, care, and use of abrasive wheels is dealt with in AS 1788.2, Abrasive Wheels, Part 2—Selection, Care, and Use.
